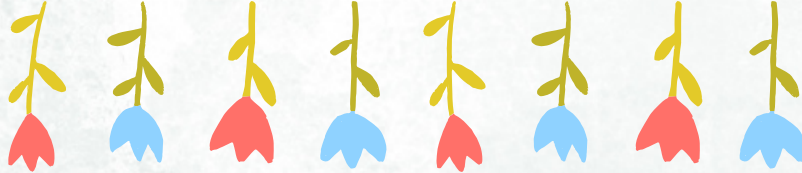

HOW DID LABOUR DAY START?

On April 21, 1856, stonemasons at the
University of Melbourne marched to
Parliament House to push for an
eight-hour working day. An
agreement with employers for a 48-
hour week was eventually reached
and Australian workers welcomed
the new eight-hour day.
This led to Australia having one of
the most progressive labour
environments in the world by the
early 20th Century.

a day. A fair day's work, For a fair
